- ❖ Student with travel and tourism industry related experience (preferred)
- Letter of Recommendation(s) Recommendations should reflect the person's opinion regarding your potential for achieving a successful career in this industry and why. Recommendations should be selected from a faculty member, academic advisor, or work related supervisor. ANY APPLICANT RECOMMENDED BY A BOSTON SKAL MEMBER WILL BE GIVEN FIRST CONSIDERATION. PREFERRED CONSIDERATION WILL ALSO BE GIVEN TO RECOMMENDATIONS FROM ANY OTHER SKAL MEMBER.
